Dear Prospective Member:

This is your membership application packet, which is designed to introduce you to the Ventura Yacht Club and guide you through the procedures involved in becoming a member. Included in this packet are a schedule of membership fees and a membership application. Please look them over carefully.

There are several membership options available to fit your individual needs. Most memberships are "Regular." A Regular member enjoys all rights and privileges afforded by the Ventura Yacht Club including the right to vote on Club business and hold elective office.

To become a Regular member, you must submit a completed application signed by three sponsors (current Club members) and include a check for \$397.00 (1/4 of the Initiation Fee). The Club's Board of Directors will review your application at its next scheduled meeting (third Thursday of each month). Upon review and acceptance by the Board, you will receive confirmation along with a statement of remaining fees due and payable. You will then be required to purchase a Membership Certificate. Your purchase can be from the Club directly (\$2,000.00) or you may purchase a Certificate from any member (in good standing) wishing to sell. A list of memberships for sale will be available to you upon acceptance of your application.

Accompanying this application is the sum of \$397.00 representing ¼ of the \$1,585.00 Ventura Yacht Club Initiation Fee. If application is not accepted, I understand that all monies paid herewith will be returned to me.

Upon election to membership in the Ventura Yacht Club, I agree to obtain a membership certificate, to pay the remainder of the required \$1,585.00 Initiation Fee (\$1,188.00), to pay the prorated Annual Dues due for the remainder of the initial year (currently annual dues are \$1,813.00), and pay the pro-rated Quarterly Fixed Participation fee of \$106.00.

Policy Title: Procedures for Late Payments and Late Fees

All dues, assessments, fees and charges incurred by a member during a month are deemed billed as of the first day of the immediately following month, regardless of the date of actual receipt by the member and are payable within 15 days of billing.

If payment is not received by the Club within 30 days, the member will be advised that his account is past due and a late charge will be applied if not paid within 60 days of the original billing.

If payment of the original billing is not received by the Club within 60 days, the member will be advised by letter that his account is delinquent, a late charge of 1.5% will be assessed each month their account remains in arrears, and all charging privileges will be suspended. Charging privileges will only be reinstated when all charges including those incurred subsequent to the original delinquency are paid in full. The member will be advised to develop and agree to a payment plan acceptable to the Club.

If payment of the original billing is not received by the Club within 90 days, the member will be advised by letter that in addition to the above, membership rights have been suspended and the account referred to the Board of Directors for possible sanction or termination of membership.

Failure to develop, agree, maintain and adhere to the payment plan will subject the member to Club action. The Club will be entitled to remove the member's boat or property from the Club's property, may place a lien upon the member's boat or property for any unpaid balance owing the Club and may initiate appropriate legal action as appropriate.

Failure to agree, maintain and adhere to the payment plan anytime after 120 days of the original billing will subject the member to expulsion from the Club by the Board, pursuant to the procedure in Bylaw Article VII, Section C.



TRIAL MEMBERSHIP AGREEMENT

I hereby apply for Trial membership in the Ventura Yacht Club. If approved as a Trial Member, I agree to abide by the Articles of Incorporation and Bylaws of the Ventura Yacht Club and other rules and regulations as may be adopted. I also understand my membership may be subject to any rate change in monthly dues that may be adopted in accordance with the provisions of the Bylaws of the Ventura Yacht Club.

I understand the Ventura Yacht Club membership is a closed membership and should I wish to transfer to Regular membership I must obtain an existing membership stock certificate by one of the following methods: (a) Purchase from a member in good standing; (b) Purchase from a member not in good standing and paying all of the outstanding debts and other obligations owed by the member/owner of the certificate to the Ventura Yacht Club; (c) Transfer of a certificate from within my immediate family; (d) Purchase a membership certificate directly from the Ventura Yacht Club.

Attached hereto is the sum of \$151.00 representing one month's dues and I also understand that the same amount is due and payable on the first day of every month for 12 months or until I change my membership status. I will also be required to pay a quarterly Fixed Participation Fee of \$106.00. If this application is not approved, all monies will be returned to me.

I also understand that this Trial membership is only for a 12-month period and cannot be extended. I understand that I can obtain Regular membership status at any time during this 12month period. I understand that with this Trial membership I have no voting rights within the Club or the rights to charge any monies on my account.

TRIAL MEMBERSHIP RULES

The Trial membership will be for a 12-month period.

The Trial membership must be approved by the Board of Directors.

The Initiation Fee will be waived during Trial membership.

Trial member is to pay 1/12 (currently \$151.00) of Regular member Annual Dues per month and a Quarterly Fixed Participation Fee of \$106.00. Current Annual Dues are \$1,813.00.

Trial members may occupy berths only if no eligible Regular, Senior or Life member requests that berth. When an eligible Regular, Senior or Life member requests the berth, the Trial member shall be given 30 days' notice to vacate.

If the Trial member submits an application to become a Regular member prior to receiving a notice to vacate then they may keep the berth assignment. Failure on the part of the Trial member to follow through with the change to Regular membership shall result in termination of the temporary berth assignment.

By the anniversary date of a Trial member desiring to become a Regular member, he/she will have to be re-approved by the Board of Directors and pay in full the Initiation Fee plus the dues (prorated). He/she will also have to purchase a Certificate within 30 days.

The Trial member will have the right to attend all functions at the Club but will not have any voting rights and will be on a cash only basis.

Policy Title: Procedures for Late Payments and Late Fees

Failure to develop, agree, maintain and adhere to the payment plan will subject the member to Club action. The Club will be entitled to remove the member's boat or property from the Club's property, may place a lien upon the member's boat or property for any unpaid balance owing the Club and may initiate appropriate legal action as appropriate.

Failure to agree, maintain and adhere to the payment plan anytime after 120 days of the original billing will subject the member to expulsion from the Ciub by the Board, pursuant to the procedure in Bylaw Article VII, Section C.
