### **By chartering a boat and/or other equipment, you are accepting the following lease/hold harmless agreement:**

Charterer hereby assumes all risk of injury to any person or property from any cause whatsoever in connection with the possession and use of the Chartered Boat and Equipment. Charterer hereby indemnifies and holds Ventura Yacht Club harmless from any claim, action, proceeding, damages, and liabilities, including reasonable attorney's fees and court costs, arising from or in connection with the Charterer's possession, use, and return of the Chartered Boat and Equipment. The Charterer shall maintain the Chartered Boat and Equipment clean and presentable and in the same condition of repair as when accepted at the beginning of the Charter Term. Particular attention should be given to the hull's bottom, which can become scratched if proper care and facilities are not provided when removing the boat from the water and storing on shore. Charterer hereby assumes all risk of loss and damage to the Chartered Boat and Equipment including lost or stolen gear.
